available only through a sole source. These were 2024 budgeted items. The prices for the

control panels are as follows:

1. Buford Dam Road Pump Station #1 \$143,752.24

2. Sanders Road Pump Station \$185,669.23

**Total** \$329,421.47

of two (2) wastewater pumping station control panels for a total of \$329,421.47. The

motion carried 4-0 with Joey Cochran absent.
