There was a special-called joint meeting of the City Council of the City of Cumming and the Forsyth County Board of Commissioners on Thursday, June 20, 2024 at 4:00 P.M., in the Commissioner's Meeting Room of the Forsyth County Administration Building. Pursuant to Section 10 of the Charter of the City of Cumming, notice was given and properly posted as required by law. All members of Council were present with the exception of Chad Crane and Susie Carr. Mayor Troy Brumbalow called the meeting of the City Council to order by asking for a motion to open the meeting. A motion was made by Joey Cochran and seconded by Jason Evans to open the meeting. The motion carried 3-0 with Councilman Crane Councilmember Carr absent. The introduction of all Forsyth County Board Members and staff was made along with the Mayor, City Council and staff of the City of Cumming.

**II. Adoption of Agenda:** A motion was made by Christopher Light and seconded by Jason Evans to adopt the agenda as presented. The motion carried 3-0 with Councilman Crane and Councilmember Carr absent. The Forsyth County Board of Commissioners approved their agenda and the meeting began.
